# **Privacy Policy for LinkKlipper**

#### 1. Introduction

This Privacy Policy describes the policies and procedures of Codebox ("we," "our," or "us") regarding the collection, use, and disclosure of information we receive when you use LinkKlipper, a Chrome extension available exclusively through the Chrome Web Store. LinkKlipper is designed to allow users to extract links from websites quickly and efficiently. We value your privacy and are committed to ensuring that your personal information remains protected. This document explains, in detail, our practices and your rights regarding the information you provide or that is collected automatically while using LinkKlipper.

### 2. Information We Collect

We respect your privacy and are transparent about our data practices. LinkKlipper does not collect personally identifiable information such as your name, email address, phone number, or physical address. There are no forms within the extension to capture any personal data, and registration is not required to use the extension.

We do, however, use Google Analytics to gather aggregated, anonymized usage data. This data helps us understand how our users interact with the extension and which features are most useful. The information collected includes:

- Pages visited within the extension interface
- Frequency of feature usage
- Device type, browser version, and operating system
- General geographic location (country/region, not exact address)

Google Analytics may use cookies or similar technologies to collect this information. However, the data is aggregated and does not directly identify any individual user. For more information, please refer to Google's Privacy Policy: https://policies.google.com/privacy

#### 3. Permissions Used

To function as intended, LinkKlipper requires the following Chrome permissions:

- storage Allows the extension to store user settings and preferences locally on the device.
- activeTab Grants access to the currently active tab when the extension's action is invoked, so that it can extract links from the page.
- scripting Enables the extension to inject scripts into web pages for link extraction.
- contextMenus Allows the extension to add custom items to the browser's context menu for quick link extraction.
- management Lets the extension read information about installed extensions, which can help with compatibility checks.

These permissions are used exclusively for the core functionalities of the extension. No personal or sensitive data accessed through these permissions is transmitted to our servers or shared with third parties.

## 4. Data Sharing

We do not sell, rent, or trade any information to third parties. The only third-party service integrated into LinkKlipper is Google Analytics, which is used solely to collect anonymized usage data for

performance monitoring and feature improvement.

### 5. Data Security

Although LinkKlipper does not store personal information, we recognize the importance of safeguarding all forms of data. We rely on Google's security infrastructure to protect the analytics data collected. Additionally, we continuously review our extension's code and permissions to ensure they comply with Chrome Web Store policies and industry best practices.

## 6. Your Rights

Because LinkKlipper does not collect personally identifiable information, there is no personal data to access, modify, or delete. If you wish to limit or disable the collection of analytics data, you can adjust your browser's privacy settings or use privacy-focused browser extensions to block analytics tracking scripts.
